The Foot Patrol observed, recorded and/or reported the following:

When reporting on dogs either on or off leash (69 total reports noted in the log book) the total was 126 on leash, and 90 off leash. Much better than past, but still needs work.

Frequently reported in notes: volume of cigarette butts, trash, and broken glass including bottles and car windows.

Often reported in log book: Finding condoms, needles and graffiti

Log book entries worth noting in this report:

- 1. Finding damaged park property including benches, gates, painted out street lights.
- 2. Vandalism including graffiti, tipped over porta johns, carved names in benches
- 3. Huge amount of trash following 4th of July (park needs more security that night)
- 4. Twice provided extra help to find missing elderly/disoriented people
- 5. Found and turned in wallets, purse, computer case, keys, etc.
- 6. Turned in numerous cards to S. E. Precinct with ID of vehicles where valuables left in sight (e.g., purse, phone, money, luggage, etc.)

Services provided and noted:

- 1. Provided minor first aid (band aids, etc.) upon request.
- 2. Reported a flasher to police
- 3. Removed materials from several "homeless" camps; bedding, mattress, etc.
- 4. Reported a broken water pipe in picnic area B
- 5. Often locked utility doors left unlocked
- 6. Twice, assisted with elderly, disoriented walkers
